1. Introduction

Universiti Brunei Darussalam (UBD), through its AI SENSE Unit, invites quotations from suitably qualified vendors for the design, development, integration, testing and delivery of the software modules specified in this document, aligned to the University's undergraduate curriculum framework (Senate-approved; effective Academic Year 2026/2027).

This document is the complete technical specification for the engagement. The scope covers seven functional modules — Academic Progress & Advising; Graduation Audit; Attendance Tracking (Web); Class / Tutorial / Practical Timetabling; Transcript Request, Issuance, Verification & Online Payment; the Dynamic Approval-Workflow Engine & Unified Action Queue; and Notifications, Communications & Background Processing — together with the supporting Client UAT, FAT & Go-Live item. Database design & modelling is delivered within each module, and the existing design system is reused; neither is separately priced (see Section 2). The delivered system must integrate with the University's existing student management system and the UBD student admission system, and vendors must deliver all items in Section 2 as a complete, integrated and production-ready system.

1.1 Out-of-Scope Capabilities

The following capabilities are out of scope for this quotation and must not be proposed, designed for, or priced. The system shall nonetheless be built so they can be integrated later without architectural rework — interface boundaries, data contracts and event channels specified in a forward-compatible manner:

- Examination timetabling — venue allocation, seating plans and invigilation duties, including combined scheduling across multiple programme cohorts
- Institution-wide reporting, analytics and administration — system administration, role & permission management, identity governance, system configuration and academic-calendar management
- Integration with locally developed AI / ML inference services
- Staff Record Management — record lifecycle, role assignment and delegation, Letter Wizard / Manager
- Room & Venue Management — catalogue, availability, booking and utilisation analytics

2. Scope of Work

The vendor shall design, develop, integrate, test, document and deliver all items listed in the table below — the complete scope of this quotation. Each item is a distinct deliverable subject to the acceptance criteria in Section 5; partial quotations will not be considered. Database design & modelling (entity-relationship diagrams, per-module schema, indexing and a data dictionary) is delivered within each module and must conform to the University's existing data architecture; it is not separately priced. The existing UI/UX design system is reused and extended (WCAG 2.1 AA) — no new design system is to be created and it is not separately priced.

The capabilities listed in Section 1.1 are excluded from this scope; vendors must not include design, effort or pricing against them.

3. Technology Requirements

All development under this quotation must conform to the technology stack of the University's existing student management system. Only the scope-specific usage and the additions for this engagement are summarised below; all other backend, API and security requirements follow the University's existing student management system unchanged. Any deviation must be declared in the submission and approved by UBD in writing before work commences.

3.4 API & Security Requirements

The API layer and Security & Code Quality requirements are exactly as implemented in the University's existing student management system and are not restated here: RESTful APIs under /api/v1 documented with OpenAPI 3.0 (Swagger); Laravel Sanctum token authentication; the standard JSON envelope, cursor pagination, request throttling and central API-gateway registration; RBAC via Laravel Gates and Policies with a documented permission matrix; Form-Request input validation; immutable MongoDB audit logging of all create / update / delete on academic and attendance records; TLS 1.2+ in transit and AES-256 at rest; PHPStan level 8 and Laravel Pint passing with zero errors; minimum 80% test coverage; and secrets via environment configuration only.

4. Testing, Documentation & Go-Live

The vendor is responsible for the full testing lifecycle, documentation and go-live process for all delivered modules, including integration testing against the University's existing student management system.
